It has been a whirlwind year for Minnesota RTAP! With the assistance of the RTAP advisory committee, RTAP supported training in Minnesota through a combination of in-person workshops, online training, and webinars. RTAP created a <u>strategic plan</u> that will guide their decisions moving forward so RTAP can best serve the transit agencies of Greater Minnesota. Here are a few highlights from the year:

- Launched the Minnesota RTAP website, streamlining training registrations, record keeping, scholarship applications, and announcements.
- Hosted 48 in-person workshops, 9 online courses, and 7 webinars.
- Approved 33 scholarships to attend a variety of training events.
- Launched the pilot year of the Leadership Training Program, training nearly 40 executives, managers, and supervisors from across the state.







Overview of your user behaviors





What do users see when they are in your website?






