# **Year in Review**

This year saw transit agencies in Minnesota increasing their engagement across the board with RTAP. Collaboration was a big theme this year: in the spring of 2022, RTAP hosted two large peer-to-peer workshops and transit agencies came together to create a comprehensive plan and set of resources to meet the new ELDT requirements. Here are a few highlights from the year:

- Developed adaptable ELDT resources for agencies to use to make meeting the new requirements easier, from PowerPoints, to tests, to checklists.
- Streamlined the scholarship process, with the addition of per person maximums, eligibility guidelines, and reimbursement policies.
- Hosted 8 in-person workshops, 9 online courses, and 11 webinars.
- Reimbursed over \$15,000 in scholarships to attend a variety of local and national training events.

We look forward to serving the Greater Minnesota transit community in the year to come and invite your feedback and participation!



# **Scholarship Report**

# \$15,000+

### In Scholarships Awarded

Minnesota RTAP worked with the advisory committee to refine the scholarship guidelines and eligibility requirements this year. The full guidelines <u>may be found here</u>. RTAP funds scholarships for FTA-funded 5310 and 5311 agencies and Tribal Transit providers. Systems receiving FTA Section 5311 funding are encouraged to use operating dollars whenever possible prior to requesting a scholarship. Per person per year maximums were implemented, including an in-state event maximum of \$1,000 and an out-of-state event maximum of \$2,500. From September 1, 2021 to August 31, 2022, RTAP funded \$15,072 in scholarships. Many of the scholarships noted here were approved but not yet reimbursed because they are for events that are forthcoming.

#### **Definitions**

**New Users:** The number of first-time users during the selected date range.


**Pageviews:** The total number of pages viewed. If a user revisits this page, each visit is counted as a pageview.

**User:** A single person logged in to a single device (each device used will register as a different user)


### **Comparing 2022 to 2021**

- 52.29% increases in sessions




