## Year in Review

This year, RTAP focused on providing key training in a variety of formats, from an 8-month intensive leadership training program to 1.5-hour webinars on key topics.

Highlights from this year included:

- 63 agency staff participated in peer roundtables, sharing policies, ideas, and resources to increase collaboration around transit's toughest challenges.
- The second program of the Leadership Training Program (LTP) had 39 graduates across three levels: executive, manager, and supervisor/lead driver. The program was rated highly by participants and increased participants' core leadership skills and peer-to-peer connections.
- RTAP doubled the number of in-person events organized and tripled the number of webinars hosted over last year.
- The weekly newsletter click rate of 8% was four times the industry average of 2%, and the open rate kept pace with the industry average of 40% at 34%.
- Diversity, Equity, and Inclusion training was a key priority this year, including 4 interactive sessions with transit agency staff led by Equity Elephant Consulting, LLC.

We look forward to another year of training and professional development for Greater Minnesota transit agencies!

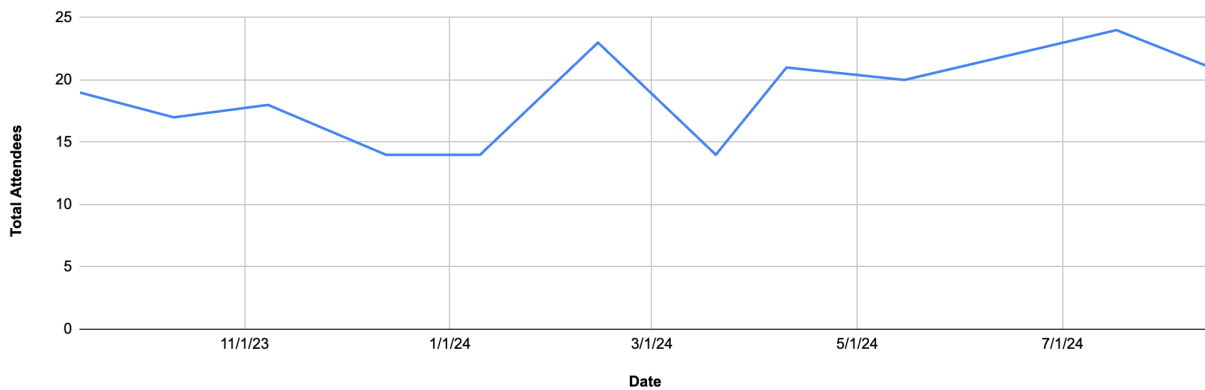

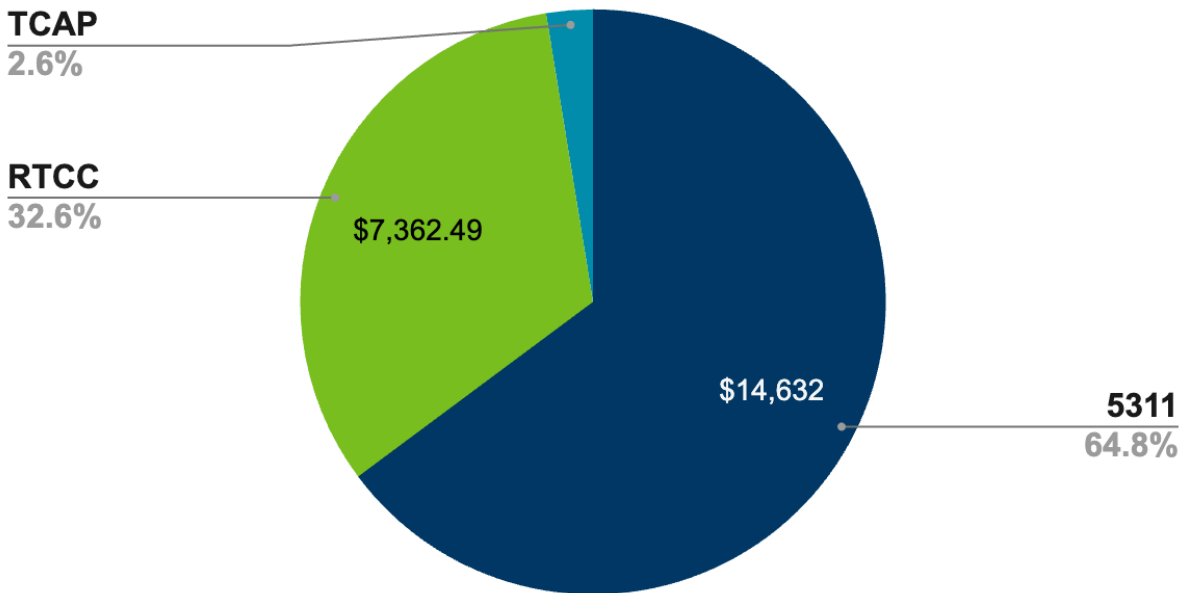

Google Analytics introduced a new measurement system (Google Analytics 4) that changed some of the definitions and measurement tools compared to previous annual reports.

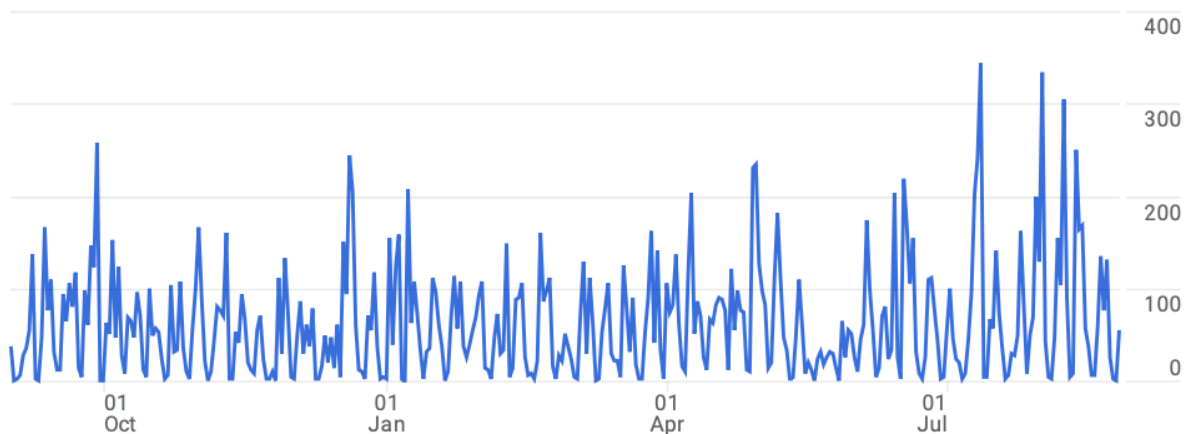

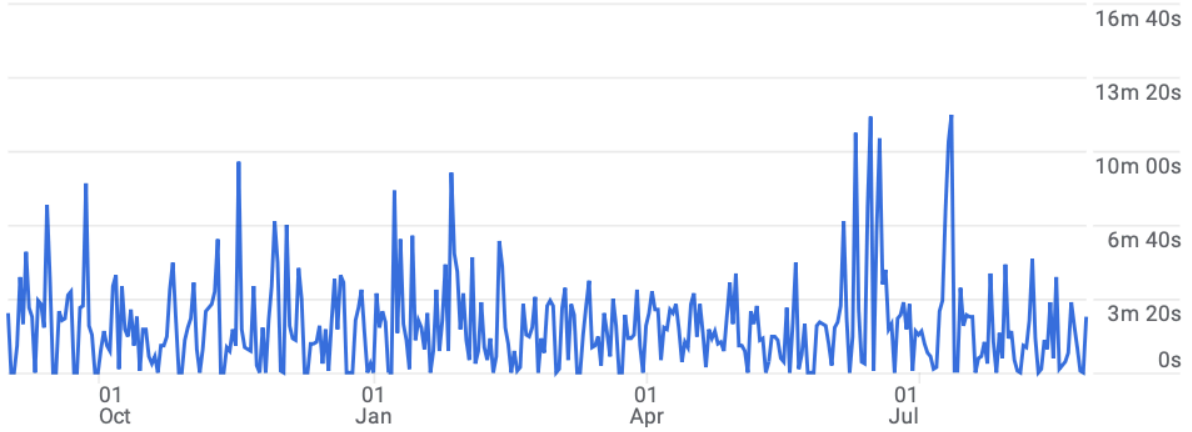

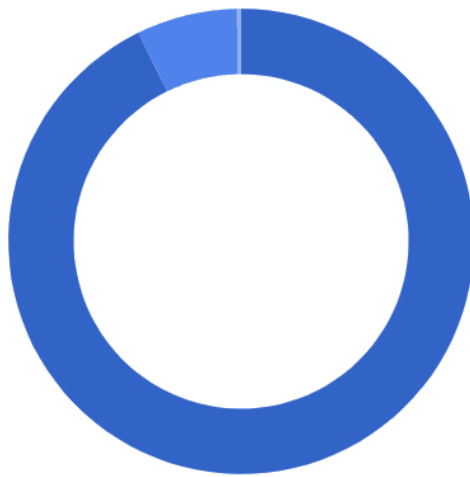
